## What you need for your dog to board or attend Day Care at Wagg-n-Purr Retreat, LLC

- Reservations are required. Schedule early to ensure availability.
- Completed and signed Boarding Agreement.
- Current vaccination record – *DAPP, Rabies, and Bordetella.*
- **\*\*Dogs must be at least 12 weeks old and completed a minimum of 3 (three) puppy vaccinations along with Bordetella.\*\***
- We strongly urge dogs over 7 months old be spayed or neutered.
- No female dogs in heat.
- No aggressive dogs allowed.

## Veterinarian recommended prevention regime (to help protect you, your family, your dog, other guests, and caretakers from contagious diseases, fleas, ticks, intestinal parasites, etc.)

- Current vaccinations for DAPP, Rabies and Bordetella.
- Flea/tick protection – monthly topical treatments
- Monthly heartworm prevention which includes intestinal parasite control.
- Broad spectrum “deworming” for intestinal parasites at least twice a year.

## Items you may bring with your dog when boarding

- Food – in a container labeled with dog’s name, feeding schedule and amount of food given at each feeding. If food is not provided, your dog will be fed “house food” at a **rate of \$1.00 per day in addition to boarding charges.**
- All medications must be clearly labeled with dog’s name, dosage, and frequency of administration; a **rate of \$1.00 per day in addition to boarding charges.**
- Treats, toys, or bones – labeled with dog’s name
- A blanket, towel, or article of clothing.
- Include an inventory of what is brought with your dog.

## Items you may bring with your dog while in Day Care

- Food – portioned in a container labeled with dog’s name and time for feeding.
- Treats – labeled with dog’s name.
- One blanket – labeled with dog’s name.

**Boarding and Day Care Dogs will play and probably (hopefully!) get DIRTY and STINKY! If you would like for us to bathe your dog, let us know when you drop them off. Let us know scheduled time of pick-up also so they can play as long as possible!**

Owner agrees that the dog shall not leave Waggn-Purr Retreat, LLC until all charges are paid to Waggn-Purr Retreat, LLC by Owner. Waggn-Purr Retreat, LLC shall have and the Owner hereby grants to Waggn-Purr Retreat, LLC a lien on the dog to secure the payment of any and all charges resulting from the boarding or grooming of a dog at Waggn-Purr Retreat, LLC. The owner agrees that in the event the boarding or grooming charges are not paid when due in accordance with this agreement, Waggn-Purr Retreat, LLC may exercise its lien right by notifying the Owner by certified mail with return receipt requested addressed to the Owner at the address given when the dog is delivered of the unpaid charges and that if the unpaid charges are not paid within 10 days of the mailing of the notice, the dog will be deemed abandoned by the Owner and sold at either a public or private sale. If Waggn-Purr Retreat, LLC does not succeed in selling the dog within a reasonable time, not to exceed an additional 10 days, Waggn-Purr Retreat, LLC is authorized to turn the dog over to the nearest Humane Society or Animal Shelter. The Owner shall remain liable for any unpaid charges plus a reasonable attorney's fee in the event of collection efforts in the event a sale of the dog does not secure payment of the amount due. All monies realized by Waggn-Purr Retreat, LLC at any sale over and above the charges due shall be paid by Waggn-Purr Retreat, LLC Owner.

At Waggn-Purr Retreat, LLC the safety, security and care of your dog is the most important thing we do. **For your protection, only the Owner or the person listed as the authorized pick up person will be able to pick up the dog. Some conditions are unavoidable in boarding facilities, such as but not limited to weight loss, hair loss, upper respiratory infections, bronchitis, diarrhea, and parasites. I understand that all dogs admitted must be protected against communicable contagious diseases and must be free of parasites. This will help to provide for a healthier environment for all.

I understand the conditions for boarding my dog in Waggn-Purr Retreat, LLC, and by signing this release and waiver, I am agreeing to hold Waggn-Purr Retreat, LLC, its owners and associates harmless from any and all claims for damages or injuries suffered by, or in any way relating to my dog's stay at Waggn-Purr Retreat, LLC.
