What you need for your cat to board or attend Day Care at Wagg-n-Purr Retreat, LLC

- Reservations are required. Schedule early to ensure availability.
- Completed and signed Boarding Agreement.
- Current vaccination record – **Rabies, FVRCP (FELINE DISTEMPER), FELINE LEUKEMIA RECOMMENDED.**
- Cat must be at least 12 weeks old and completed a minimum of 2 kitten vaccinations.
- We strongly urge cats over 7 months old be spayed or neutered.
- No aggressive cats allowed.

Veterinarian recommended prevention regime (to help protect you, your family, your cat, other guests, and caretakers from contagious diseases, fleas, ticks, intestinal parasites, etc.)

- Current vaccinations for FVRCP, Rabies (required). Feline Leukemia is recommended. On the schedule your cat's Veterinarian recommends.
- Flea/tick protection – monthly topical treatments are recommended.
- Broad spectrum “de-worming” for intestinal parasites at least twice a year.

Items you may bring with your cat when they are boarding

- **Food** – in a container labeled with cat's name, feeding schedule and amount of food given at each feeding. If food is not provided, your cat will be fed “house food” at a **rate of \$1.00 per day in addition to boarding charges.**
- All medications must be clearly labeled with cat's name, dosage, and frequency of administration; a **rate of \$1.00 per day in addition to boarding charges.**
- Treat or toys – labeled with pet's name
- A blanket, towel, or article of clothing
- Please include an inventory of what is brought with your cat.

Items you may bring with your cat while they are in Day Care

- **Food** – portioned in a container labeled with cat's name and time for feeding.
- **Treats** – labeled with cat's name.
- **One blanket** – labeled with cat's name.

Owner agrees that the cat shall not leave Wagg-n-Purr Retreat, LLC until all charges are paid to Wagg-n-Purr Retreat, LLC by Owner. Wagg-n-Purr Retreat, LLC shall have and the Owner hereby grants to Wagg-n-Purr Retreat, LLC a lien on the cat to secure the payment of any and all charges resulting from the boarding or grooming of a cat at Wagg-n-Purr Retreat, LLC. The owner agrees that in the event the boarding or grooming charges are not paid when due in accordance with this agreement, Wagg-n-Purr Retreat, LLC may exercise its lien right by notifying the Owner by certified mail with return receipt requested addressed to the Owner at the address given when the cat is delivered of the unpaid charges and that if the unpaid charges are not paid within 10 days of the mailing of the notice, the cat will be deemed abandoned by the Owner and sold at either a public or private sale. If Wagg-n-Purr Retreat, LLC does not succeed in selling the cat within a reasonable time, not to exceed an additional 10 days, Wagg-n-Purr Retreat, LLC is authorized to turn the cat over to the nearest Humane Society or Animal Shelter. The Owner shall remain liable for any unpaid charges plus a reasonable attorney's fee in the event of collection efforts in the event a sale of the cat does not secure payment of the amount due. All monies realized by Wagg-n-Purr Retreat, LLC at any sale over and above the charges due shall be paid by Wagg-n-Purr Retreat, LLC Owner.

At Wagg-n-Purr Retreat, LLC the safety, security and care of your cat is the most important thing we do. **For your protection, only the Owner or the person listed as the authorized pick up person will be able to pick up the cat. Sunday pick up and drop off is permitted. Please let us know when you make reservations that you wish to have after hours pick up or drop off. We will gladly accommodate this during our normal feeding/walking hours. Sunday hours will be 7:30-8:30 am and 4:00 – 5:30 pm.

The Owner agrees to be solely responsible for any and all acts or behavior of the cat while it is in the care of Wagg-n-Purr Retreat, LLC.

I understand the conditions for boarding my cat in Wagg-n-Purr Retreat, LLC and by signing this release and waiver I am agreeing to hold Wagg-n-Purr Retreat, LLC, its owners and associates harmless from any and all claims for damages or injuries suffered by, or in any way relating to my cat's stay at Wagg-n-Purr Retreat, LLC.

While we do our very best to care for your cat, Wagg-n-Purr Retreat, LLC cannot guarantee the health of your cat during their stay. Some conditions are unavoidable in boarding facilities such as but not limited to weight loss, hair loss, upper respiratory infections, bronchitis, diarrhea, and parasites. I understand that all cats admitted must be protected against communicable contagious diseases and must be free of parasites. This will help to provide for a healthier environment for all.
